Chief Executive Officers are asked to invite applications from suitably qualified persons to fill the vacant posts of **Building Officer (SOG/ST 5) (2 posts)** in the **Trelawny Municipal Corporation** salary range \$1,271,811 – \$1,511,784 per annum and any allowance(s) attached to the post:

Job Purpose:

To enforce, guide and promote orderly Building and Development activities within the parish as stipulated within the Development Order and Town and Country Act 1957.

Job Responsibilities:

- 1. Receives and assesses Building Applications and Subdivision applications
- 2. Executes stop, enforcement and encroachment Notices on persons carrying out illegal buildings and other structures
- 3. Prepares Estimates/Bill of Quantities and Contract documents for work to be done on Corporations buildings
- 4. Makes site visits and recommendations for building approvals
- 5. Carries out steelwork inspections on approved buildings and other structures on sites
- 6. Monitors and supervises work done Corporation's buildings
- 7. Attends meetings as instructed by Superintendent, Roads and Works e.g. Physical Planning, Environment & Employment & Development, Poor Relief, Disaster Preparedness Committees etc.
- 8. Prepares payment vouchers for work done
- 9. Inspects and makes recommendations for retentions to be paid for work done
- 10. Monitors activities of Life Guards at Public Beaches
- 11. Prepares drawings and specifications for all building works, proposed by the Corporation
- 12. Monitors activities of Watchmen at the Municipal Corporation's Building
- 13. Forwards information regularly and on time so that a proper report to the relevant Committee Meetings can be done in written form
- 14. Submits to the Superintendent, Roads and Works at least three (3) days before Committee Meeting all processed plans for building and other relevant information, after site inspections are carried out along with monthly Building Officer's Report of activities that was done during the month
- 15. Makes periodical checks on illegal structures to ensure that persons comply with Notices served on them
- 16. Promotes orderly development within the parish as it relates to the Corporation's Laws and By-Laws and to ensure that land listed in Development Order for the parish is used only for what is specified
- 17. Attends meetings of Non-Governmental Organizations, neighbourhood watch and other community-based organizations, representing the Superintendent, Roads and Works.
- 18. Supervises Mechanical Unit Operators/Drivers
- 19. Inspects Early Childhood institutions
- 20. Inspects places and Amusement
- 21. Conducts Burial Site Inspections on Family Plots
- 22. Inspects Villas/Resorts for annual TPDCO licensing
- 23. Monitors Public Cemeteries and Cemetery Keepers
- 24. Enforces and monitors the International Building Codes, Building Act, etc. and other Regulations
- 25. Investigates complaints made by residents concerning any development in the Parish.
- 26. Monitors and enforces orderly development/s and give advice to persons as it relates to the procedure in carrying out development/s throughout the Parish.

Minimum of two (2) years supervisory experience in carrying out major infrastructure work
