JOB PURPOSE

Under the supervision of the Superintendent, Roads& Works, the Superintendent of Minor Water Supplies is responsible for the general overseeing of the Municipal Corporation Minor Water Supply Systems.

KEY RESPONSIBILITY

- Responsibility for the day to day management and supervision of the Minor Water
- Supply Department of the Corporation.
- Manage the activities of the Plumbers, Assistant Plumbers and Chlorine Operators.
- Ensure procurement of materials required to maintain water supplies and for operation of the department.
- Prepare monthly reports on the water supply systems.
- Ensure that water bills are prepared and distributed on a monthly basis.
- Ensure the prompt collections of water rates from customers connected to the Corporation's minor water supply systems.
- Investigate applications for water supply and make appropriate recommendations.
- Ensure that customers get continuous supply of potable water.
- Visit entombments and catchments to observe general conditions of these facilities and take corrective action where necessary.
- Attend to systems breakdowns by assessing the problems and making arrangement for trucking of water if necessary.
- Ensure that water trucks are routed to drought stricken areas.
- Redeploy department resources as the need arises.
